STATEMENT OF CLAIM

The above named Plaintiff(s) sue the above named Defendant(s) and alleges:

1. This is an action for damages which do not exceed the amount of \$8,000.00 exclusive of costs, interest and attorney fees.

The Plaintiff(s) claims the amount of \$ 8,000.00 as being due from the Defendant(s) and They decided not to deliver what they promised and damaged my Nintendo Gameboy Bomberman Max Red Challenger. Furthermore they allocate an incorrect low grade which is not comparable to what is stated in their grading structure. They have been illicit and also have denied me my refunds. I have been discriminated against. the response to my complaint was not to my satisfaction, there was unreasonable delay, little or no communication. I was mislead from the very beginning. T. My human rights have been violated too. hey have refused to cancel my orders and provide a refund due to their retarded incompetence. I have stated everything in my emails. They have discriminated against me on the basis of my personal characteristics of being a single straight Asian Bangladeshi Moslem male from the streets of Sparkhill, Birmingham, West Midlands, UK. The person on the phone threatened to call the police on me, however when I mentioned I would be suing them all, this irrelevant retard who refused to provide their name was about to have what appeared to be a stroke or cardiac arrest. I was really worried for her health and well being and was thinking of calling an Ambulance but the NHS ambulance would take hours to attend so I am sure her friends are happy to help. I have requested via emails that I would like all court cases and everything to be made public for fellow good citizens to view. I would furthermore like the court case to be publicly live streamed and for it to be uploaded on social media and if they have nothing to hide they will upload it on their social media accounts ? For the UK CGC I will be filing a county court claim within the UK as my complaint hasn't been answered and as I mentioned in point 2, the lady on the phone came across as extremely threatening and said she would call the police on me; for what reason ? My past emails haven't been answered, I have not been offered any apology or any refunds.

Additionally they have made promises and their website states they make guarantees and promises which they have not lived up to or delivered. Their staff have been most unhelpful and are unable to deal with basics or answer any basic questions. They caused me bullying, harassment, entrapment and victimisation. It has affected my mental health and impacted me personally due to the headaches and stress. Furthermore the emotional distress, has left me feeling unwell, anxious and caused me depression too. I have anxiety, feeling at unease and I fear for my life. The racial discrimination and Islamophobia caused by CGC video games have at times have lead me to have thoughts of suicide. The cases are flimsy and the grade I have received is not fair and they have not been impartial as they market. Their cases are worst than the \$15 dollars sliding bottom acrylic cases and compared to other grading companies they are just rubbish; not as advertised. I did call the West Midlands Police, they have therefore breached the contract agreement. My freedom of speech has been denied. Why have CGC Video games blocked me on all social media platforms such as Instagram ? My posts and thread on their forum have not been published.

Wherefore, Plaintiff(s) demands judgment for damages against Defendant(s) in the above amount plus all costs of this action.
